CONCERTS INCLUDE THE BETHLEHEM BACH FESTIVAL OVER FOUR DAYS IN MAY AS WELL AS CHRISTMAS, FAMILY, SPRING, BEL CANTO YOUTH CHORUS, AND GALA CONCERTS. EIGHT OF THESE CONCERTS ENTITLED "BACH TO SCHOOL" ARE PRESENTED FOR MORE THAN 5,000 STUDENTS (GRADES 3-12) EACH YEAR IN DIVERSE SCHOOL DISTRICTS THROUGHOUT THE LEHIGH VALLEY REGION ALONG WITH ACTIVITY BOOKS AND ADDITIONAL ONLINE CONTENT. WE PRESENTED OUR TEN BACH AT NOON CONCERTS TO LIVE AUDIENCES AT CENTRAL MORAVIAN CHURCH IN HISTORIC DOWNTOWN BETHLEHEM AND AT ST. JOHN'S LUTHERAN CHURCH IN ALLENTOWN.
